Treasurer – Patty T.: distributed reports \$4357.73, had some problems with credit card machines – credit card sales were \$1500 less than normal; other expenses – special events money deposited \$1044 (will not show until September); telephone expense (phone & interet) charge for yearly website bill \$252 – normal annual charge \$102.08 loss this month \$26,356.79 – both the prudent reserve and operating account Group \$760.45; \$200 from JI Lighthouse; \$8.50 in misc donations; balance from West Ashley Group **See treasurer's report

Alt. Treasurer – Patrick: not present

Secretary – VACANT – Emily: sitting in as secretary today. Will work on getting TCIO reps info updated as we do not have a list from former secretary of contact info for TCIO reps

Communications – Eric: we had our 3rd committee meeting since changing to in house meeting, still no attendance, emailed the flyer to website chair to distribute. Please take this information back to your groups to have your communications reps attend this meeting. Pete gave me a list of people covering the answering service Monday through Friday, now have some people to reach to help with communications

Office Mgr. – Pete: good to see everyone, because of the storm, we do not have any Big Books – no deliveries last week, other than that things are going okay. Appreciate those that help – the volunteers. If anyone has an interest in doing that – must a year of continuous sobriety Considering resignation – but will not leave until there is someone to take my place

Special Events – Emily: 12 of Out Hell, Sober Bike Run is October 28, 2018 – starting at TCIO at 10 am and then will end at Step Up Club around 1:30 pm, food/fellowship at 2 pm – speaker: Matt Z. at 3 pm

2nd Annual Spiritually Lit – November 3 on Sullivan's Island – bonfire and speaker – Ray S. from Mt. Pleasant Planning gratitude dinner/speaker date TBD – sometime in November 2018 NYE to be hosted by group in District 71 – to be decided by DCM, Liz M.

Old Business:

Clark: Discussed bi-law changes – need clarification whether Alt Treasurer will be a board member. Duties to be a 2nd signer on bank account, and to assist treasurer Patty: currently 6 people on board, usually boards have an odd number of people *Requesting a sense of the groups opinions as to whether the Alternate Treasurer will be a board member? Whether this was already implied when voted to have an Alt Treasurer initially? Need Clarification of position*

Bi-Laws - Proposed changes: **To be voted on at October 2018 meeting**

Article X, Paragraph 3: The Treasurer shall transfer all amounts in the excess of \$6,000.00 operating budget to the Prudent Reserve account quarterly. The Prudent Reserve account shall contain no more than 3 months operating expenses calculated each January as 1/8 of the last two calendar years expenses. Excess funds shall be disbursed quarterly in a manner to be determined at the January and July scheduled TCIO meetings.

Patty - Ad hoc committee update, meets once a month, chair: Ken B. Reviewing bank of account information, details. Scrutinizing the bi-laws – seeing what we can and cannot do. For example, it says in the Bi-Laws – Quorum is 2/3 of the average attendance of the last TCIO meeting. We are looking at these things closely and trying to figure out wording that this to be both easily understood and accurate. Trying to "uncomplicate" this. Bi-laws are on the website but not updated, there are decisions made at past meetings that were not added to the bi-laws. Working on updating the bi-laws to reflect past TCIO minutes

Need a new secretary – will be elected at the next TCIO meeting on 10/21/18

Patty: we used to use this white board in the front office, it gives the daily volunteers, board members we need to use this board and update as there was an issue – Robert: one of the volunteers said they would talk on behalf of
