 - \$400 suggested for new TCIO printer in need of replacement. Vote Passed
 - Remainder of Overage, Approx. \$800, to be allocated to TCIO building needs IE: bathroom fan, fire extinguisher renew/update, add/replace tables for AA community use. Vote Passed
 - Note: Bylaws allow below \$500 to be spent without being brought before membership.
 - Office Mgr will work closely with Treas. for receipts and accounting purposes.
