WHAT IS A CENTRAL OFFICE?

(Tri-county Intergroup Office - TCIO is the Central office for Berkeley, Dorchester, and Charleston county AA groups) A central office (or intergroup) is an A.A. service office that involves partnership among groups in a community - just as A.A. groups themselves are partnerships of individuals. A central office is established to carry out certain functions common to all groups - functions which are best handled by a centralized office - and it is usually maintained, supervised, and supported by these groups in their general interest. It exists to aid the groups in their common purpose of carrying the A.A. message to the alcoholic who still suffers.
